



## **ERASMUS+ CALL FOR APPLICATIONS – CONDITIONS**

# For students applying for Erasmus+ study abroad programme within the framework of agreements for all subject fields

#### The aim of the call

Within the framework of the Erasmus+ mobility programme, accepted students will receive the opportunity from 1 August 2025 until 30 September 2026 to participate in a **study abroad** programme at partner universities with whom ELTE has an Erasmus agreement covering all subject areas.

The mobility can only be realized, if **the home university (ELTE) accepts the credits of the exchange study/traineeship or includes the grades and results in the diploma supplement** (except in the case of traineeships after graduation). **You can read about the credit recognition procedure** <u>here</u>.

#### **Erasmus+ scholarship winners:**

- spend min. 2 months (60 days), max. 1 semester abroad (according to the duration of the semester at the host institution) in the case of a study abroad mobility;
- do not pay tuition fee at the host university;
- have an active student status at the home university (ELTE) with receiving associated grants from and paying necessary costs to the home university;
- fulfil one part of their studies at the partner university and these subjects/credits are accepted by the home university upon arrival (before departure, the Learning Agreement for studies is planned together with the academic representative of the student at the home university.)

**20 ECTS** must be fulfilled on average in a semester. The minimum credits that must be completed at the courses is specified by the academic representative of the home university and defined by the Institute/Department's published calls. There is no minimum credit expectation for PhD students if they fulfil research activity at the partner university. Subjects and courses directly related to the student's major at the home university are accepted, while other subjects and courses will be evaluated by a separate procedure.

• might receive an Erasmus+ mobility grant for the period physically spent abroad (completing the minimum duration of the mobility – 2 months –, as well as adapting to the length of the semester abroad in the case of a study abroad mobility).

# Who can apply?

### Students

- who have student status at Eötvös Loránd University at the time of the application;
- with Hungarian nationality or registration of permanent residence permit or residence permit
- who already have at least 1 completed semester of their current studies at ELTE;
- with active student status at Eötvös Loránd University in the semester of the planned mobility;

can apply for Erasmus+ studies.

#### Further instructions in connection with the call:

- The language proficiency of the student is assessed by European Union's expectations (on-line test before and after mobility).
- Students doing Erasmus+ studies during their last semester: Mobility may last until the <u>last day of the</u> <u>examination period</u> in the last semester, but must be recognized by the university before graduation. It is the student's responsibility to initiate the recognition process. It is the student's responsibility to consult with the host institution ensuring the Transcript of Records is issued in time.

#### About the amount of scholarship and terms

According to the regulations of the Erasmus+ programme, every student have the opportunity to get 12 months of Erasmus+ status altogether (studies and traineeship), even if it is 'zero grant' mobility. For students participating in an undivided one-tier programme, this period is 24 months. It is possible to apply with previous Erasmus+ mobility as well in the same study cycle if the 12- month-time frame (24 months in case of students of an undivided one-tier programme) has not been used. It is possible to apply for those MA or PhD students who had Erasmus+ mobility on previous study cycles.

Please note that only **1 semester per mobility<sup>1</sup> for study abroad mobilities** can be financially supported, the awarded scholarship period cannot be extended further. If you would like to stay longer than the mobility period stated in your grant agreement at your own expense, you can extend your Erasmus+ status, but you will not receive a grant for the duration of the extension (zero grant days). Based on the above, a student may return to the same host institution at least 6 months after the end of the previous mobility if they wish to apply for Erasmus+ funding for the new mobility.

Those students who were nominated by the institute/department responsible for cooperation, but were not granted financial support by the Students and Staff Mobility Committee might also travel to participate in the Erasmus programme, but they need to fully cover their costs. These students are named "zero grant students".

Awarded students are exempt from paying tuition fees to the host institution, or from any fees (such as registration fees, exam fees, laboratory use fees, or library visit fees) that students at the host university do not have to pay separately. They have the same rights and obligations as the students of the host university.

We would like to call the students' attention that the financial support does not cover all the costs that arise during their stay abroad; some costs must be covered - sometimes with pre-financing- from other sources.

## The Erasmus+ grant for study abroad mobilities consists of

- the (monthly) individual support grant and
- the one-time, single contribution travel support.

The Erasmus+ grant depends on the number of mobility days and the host country of the mobility.

## I. <u>Individual support grant</u>

The individual support grant for study abroad mobilities in the academic year of 2025/2026:

- Austria, Finland, France, Germany, the Netherlands, Ireland, Italy, Norway, Portugal, Spain: 600 EUR/month;
- Poland, Latvia, Romania: 540 EUR/month;
- Switzerland and the United Kingdom: 600 EUR/month.

## II. <u>Travel support</u>

The travel support is a one-time support for study abroad mobilities, calculated on the basis of the air distance between the headquarters of the sending and the host institutions (city) by using the <u>distance</u> <u>calculator</u> supported by the European Commission.

The amount of travel support for confirmed <u>green travel</u> is higher, if at least 51% (more than half) of the total return journey is sustainable. Based on this the amount of the travel support is as follows:

## Students in need can apply for <u>additional supports</u>:

- Erasmus+ top-up support for students with fewer opportunities: Eligible applicants will receive an additional €250/month, regardless of the type of mobility.
- SN Erasmus+ Additional financial support for students with disabilities or long-term illnesses (based on real costs): Students with disabilities or long-term illness (studies and traineeships as well) can apply for additional support for their special needs. Provided that the eligible student does not need additional support exceeding €250 per month for the mobility and has not applied for the additional financial support for students with fewer opportunities, the additional support for students will be a flat-rate amount of €250 per month.

If the student needs additional support exceeding  $\in 250$  per month for the mobility or has applied for the additional financial support for students with fewer opportunities, further additional support may be requested.

• Green travel support: As mentioned at the travel support, the amount of travel support for confirmed green travel is higher, if at least 51% (more than half) of the total return journey is sustainable between the sending and host countries. They might also receive an additional grant for max. 2-2 travel days before and after the mobility, based on the distance between the sending and host institutions.
