**International Freshman Camp
Rules and Regulations**

Szolnok 2026

Preamble

The purpose of the University Freshman Camps or Orientation Days (hereinafter: **Event**) of Eötvös Loránd University (hereinafter: **University**) is to provide an opportunity for persons admitted to the University and enrolled in the given degree program (hereinafter: **freshmen**) to get acquainted with the traditions and customs of the university upon the start of the academic year, to acquire knowledge about the most important aspects of their studies, and to help the freshmen integrate into the university student community. The camp also aims to create a safe, supportive and inclusive environment for all participants.

1. General provisions

- 1.1. The personal scope of the rules and regulations of participation of this Event (hereinafter: **Rules**) covers all persons participating in the Event, in particular freshmen, persons participating in the organization and implementation of the Event and service providers (security service, buffet, performer, etc.), as well as persons employed by them in an employment relationship or in any other legal relationship aimed at performing work, as well as (external) visitors of the Event.
- 1.2. The scope of these Rules is the university's Event **between 25-27.09.2026** at 5000 Szolnok, Tiszaleti stny. 14. (hereinafter: **Camp**) and the related external events and the duration of the joint travel to the Event, until the official closing of the Event. Participation in the Event and entry into or stay in the camp serving as the venue of the Event is only possible in compliance with these Rules.

2. Terms and conditions of participation in the Event

- 2.1. The Event is a private event, in which, in addition to freshmen, persons designated by InSINC - International Student Integration Knowledge Centre (hereinafter: **Centre**) can participate. In addition, the University's teaching staff service providers (employees of service companies) and designated public servants of the University participating in the implementation of the Event may participate in the Event as guests.
- 2.2. The participants of the Event (hereinafter: **participants**) can be classified into the following categories, depending on the purpose of participation:
 - a) **freshmen**
 - b) **organizer** (including students commissioned by the Centre to capture photos / videos)
 - c) **main organizer**
 - d) **guest**
 - e) **service provider involved in the organization of the event**
 - f) **ELTE public servant.**
- 2.3. In the case of the participants specified in point 2.2.a), the condition for participation in the Event is that the participant has been admitted to the University in the 2026 admission procedure, has reached the age of 18 before the start of the camp and has a student status at the University. A further condition for participation in the Event is that

the participant pays the participation fee and completes the online registration by the deadline.

2.4. Cancellation terms:

2.4.1. Up to 14 days before the start date of the Event, the paid participation fee can be reclaimed for a 10% handling fee.

2.4.2. After the 14th day before the start date of the Event, the paid participation fee cannot be refunded.

2.5. Upon arrival at the Event, participants are required to register with proof of identity. At the time of registration, the following documents must be filled in, handed over for verification and presented:

- a photo document suitable for proving identity,
- a document certifying registration and payment of the camp fee,
- a statement of familiarity with and compliance with these Rules and of liability.

2.6. To prove the right to participate, each participant will receive a wristband upon entry, which they are obliged to wear throughout the Event and present it at the request of the authorized persons. The wristband cannot be transferred to any other person. In case of loss or damage to the wristband, the participant is obliged to immediately notify the organizers, who can provide for its replacement – in justified cases and on a one-off basis.

3. Rights and obligations of the participants of the Event

3.1. All persons participating in the Event are obliged to comply with the provisions of the legislation, the regulations of the university institutions and these Rules, and to comply with the instructions of the main organizers and organizers to do so.

3.2. All participants participate in the Event at their own risk. All participants may use the equipment, devices and sports fields at the Event solely at their own risk. Participation in the programs and tasks of the Event is not obligatory for anyone, and no participant can be obliged to perform them.

3.3. The participant may leave the Event at any time, but the participant is obliged to notify the main organizers of this. If the participant does so before the official closing of the Event, the designated main organizer is obliged to remove their wristband upon exiting, and the person leaving is obliged to declare in writing that they have left the Event at their own risk.

3.4. The participants of the Event may notify the organizers if they do not wish to be recorded. In this case, they may receive a corresponding marking (e.g. wristband, badge). In addition, the organizers provide a camera-free zone for them. Otherwise, the official photography student organizers commissioned by the Centre may take photographs of the participants of the Event for the University, and in the absence of any objection

from the participants, even subsequently, the photos and recordings approved by the University may be published in the domestic and foreign press, media and in the University's promotional materials. All participants who appear in the recordings can only be named with their consent.

- 3.5. It is prohibited to bring prohibited substances and tools into the area of the Event. It is prohibited to bring drugs, pyrotechnic devices, accident-prone glass objects, punching, stabbing, cutting devices, objects or devices containing explosive, toxic or flammable substances, or any other objects or devices that endanger the physical integrity of others or are suitable for it. It is prohibited to use firecrackers or other alarming devices in the area of the Event, and to behave in a way that violates public order and public morals.
- 3.6. It is prohibited to bring in objects that are particularly dangerous to public safety according to Decree No. 175/2003. (X.28.) of the Hungarian Government (e.g. butterfly knives, spring knives, gas sprays, lead sticks, vipers, throwing stars, boxers, electric shockers, imitation firearms, stabbing or cutting tools with a cutting edge or a blade length of more than 8 cm) to the area of the Event.
- 3.7. The participant is entitled to bring unopened, bottled, non-alcoholic liquids with a total capacity of up to 6 liters into the area of the Event, except in the case of a heat alert ordered by the responsible state body, in which case the participant is entitled to bring in additional unopened, bottled, non-alcoholic liquids in reasonable quantities necessary to satisfy personal needs. Plastic cans, water bottles and other refillable liquid containers may only be brought into the Event area when empty.
- 3.8. It is prohibited to bring food or tobacco products into the area of the Event in commercial quantities. In the case of foodstuffs, a commercial quantity is defined as a quantity that exceeds a reasonable amount necessary to satisfy personal needs, and in the case of tobacco products, an amount exceeding 2 cartons (20 boxes) of cigarettes, 10 packs of cigarillos, 10 cigars (regardless of size), 2 cartons (20 boxes) of heating sticks, 250 grams of tobacco and 100 ml of e-liquid.
- 3.9. In Hungary, the consumption and possession of both soft and hard drugs, as well as the abuse of mind-altering substances are also punishable acts, so it is strictly FORBIDDEN to bring them to the Event! Furthermore, the consumption of drugs is prohibited during the Event and during the joint departure, in the entire area of the Event. There is no distinction between soft and hard drugs in the application of the prohibition, and violation of the ban will result in immediate exclusion from the Event. In order to comply with points 3.5-3.9, the security service will call on the participant to voluntarily present the contents of their luggage before entering the area of the Event. If this is refused, the participant may not participate in the Event. If any of the organizers or main organizers experiences drug use in any participant present at the Event venue, this will result in the immediate disqualification of that participant. The main organizers are entitled to request police assistance in case of suspicion of possession or consumption of drugs, if the person involved in the suspicion does not voluntarily present their luggage or anything in their possession at the request of the security service. A record

of the procedure must be recorded, and the person concerned and the main organizer must be present during it.

- 3.10. Acute, permanent or periodic illness, allergy or other health data may be processed by the University on the basis of a voluntary, clear and explicit declaration of intent given by the freshman on the registration interface, based on the information available there. Medicines may only be brought into the event area in officially designated packaging with the recommendation of a specialist or general practitioner, which the participant must immediately present to the medical staff together with the medication instructions, who are entitled to provide for the separate storage of the medicine in justified cases.
- 3.11. Persons with fever, infectious diseases, injured/open wounds, persons under the influence of drugs or other intoxicating substances are not allowed to enter or stay in the area of the Event.
- 3.12. The participant acknowledges that if the participant shows symptoms of an infectious disease during the duration of the Event, in view of which the medical staff deems isolation justified, the main organizers may isolate the participant in the designated area of the Event until the participant is treated or returned home, if necessary. The main organizer will decide on the isolation of the participant based on the opinion of the medical staff. The main organizer will notify the relative of the isolated person of his decision. In the event of an extremely serious/infectious or high number of cases, the medical staff will make the public health report, and the main organizer will immediately notify the Vice-Rector for International Affairs of the University.
- 3.13. In the event of an accident involving personal injury, the main organizer and the organizers – if the person providing the health care services deems it justified by the severity of the injury, also the ambulance (112) – must be notified immediately. To the best of their ability, the person providing the health care service is obliged to take care of the injured person and other necessary tasks (e.g. calling an ambulance).
- 3.14. In the event of a health emergency, the ambulance and the organizers and main organizers must be notified immediately.
- 3.15. Smoking is only allowed at the Event in designated smoking areas. Any participant who violates the rules may be excluded from the Event by the main organizers. The organizers and main organizers are responsible for cleaning up any scattered ends.
- 3.16. Lighting a fire is only allowed in the designated place, taking into account any fire bans that may have been ordered, in compliance with fire safety and accident prevention regulations, in the presence of the main organizer.
- 3.17. In the event of a fire detection, the organizers and main organizers must be notified immediately and extinguishing must be started immediately as described in the fire protection regulations. If necessary, the fire brigade must be notified (by calling 112).

- 3.18. All participants are obliged to protect natural values, assets and equipment placed at their disposal or given to their use.
- 3.19. The participants of the Event bring their movable property to the area of the Event at their own risk, the operator of the camp and the participants specified in points 2.2 b)-c) and e)-f) shall not be liable for the movable property.
- 3.20. All participants of the Event are responsible for the cleanliness of the camp. Waste must and may be disposed of in the designated place, if possible in a manner appropriate to selective collection. Upon leaving the Camp, please return the rooms in their original condition, without any items left behind.
- 3.21. In the case of open-water bathing, participants are obliged to take care of each other's physical integrity and health, taking into account the generally known accident prevention rules:
- a) bathing and the use of swimming equipment (e.g. pedal boats) may only be carried out within the area marked with buoys or where it is not prohibited by any provisions,
 - b) diving into the water is forbidden,
 - c) a person who cannot swim may only be near the shore,
 - d) it is forbidden to go into the water while under the influence of alcohol,
 - e) it is forbidden to jump into water with an overheated body,
 - f) It is forbidden to enter the water in weather conditions unsuitable for bathing.
- 3.22. Freshmen may leave the area of the Event only in justified cases, for the purpose of participating in the external program of the Event, or with the special permission of the main organizer or with an escort appointed by him, in the manner specified in Section 3.3. Leaving the Event area without permission will result in exclusion from the Event.
- 3.23. All participants of the Event are obliged to pay attention to the peace of the population and not to disturb their peace by loud or otherwise. Cars are not allowed to enter the area of the Event, except for the designated vehicles. Approved vehicles may drive in the area of the Event in compliance with the rules of KRESZ and not exceeding the permitted speed of 10 km/h. Parking is available in the parking spaces that may be marked.
- 3.24. It is prohibited to carry out commercial and marketing activities in the area of the Event without the permission of the main organizers!
- 3.25. During the Event, between 06:00 am and 06:00 pm during the day, the consumption of beverages with an alcohol content higher than 14 V/V% in any form is prohibited!
- 3.26. During the Event, it is prohibited
- a) to damage or remove from the Camp any furnishings or any utensils (especially doors, toilets, showers, toilets) in the Camp;

- b) to take tables and chairs out of the main building of the Camp;
- c) to take bedding, blankets and pillows out of the rooms of the Camp;
- d) to take plates, cutlery, glasses and food out of the canteen of the Camp;
- e) to bring any animal into the Camp buildings!

4. Consequences of violating the Rules

- 4.1. If the participant violates the provisions of these Rules, the main organizer may decide, based on the consideration of the circumstances of the case, that the person concerned:
 - 4.1.1. is warned,
 - 4.1.2. is expelled from and called on to leave the Event.
- 4.2. The main organizer is obliged to ban the participants specified in points 2.2 a)-f) from the Event if:
 - 4.2.1. repeatedly and seriously violates these Rules,
 - 4.2.2. exhibits blatantly anti-social behavior that is capable of causing serious disturbance to others or the life of the camp,
 - 4.2.3. demonstrates a manner that endangers one's own or others' life, physical integrity or health,
 - 4.2.4. commits a crime or misdemeanor (with an emphasis on the consumption and trafficking of drugs),
 - 4.2.5. seriously violates legislation or university regulations.
- 4.3. Depending on the seriousness of the case, the main organizer may decide to initiate the (criminal, civil, disciplinary) prosecution of the participant concerned.
- 4.4. Violators may not make any financial or moral claims against the University or the participants specified in Sections 2.2 b)-c) and e)-f).
